ARTICLE 15 - ASSOCIATE MEMBERS

- (a) Spouses of Honorary, Ordinary, Life, Term and Outstation Members as defined in Article 20(b) and nominees of Corporate members, will on the members' recommendation and at the discretion of the Committee be Associate Members of the Club;
- (b) If a lady joins as an Ordinary Member on the payment of the entrance fees prevailing at the time, then her husband on the wife's recommendation and at the discretion of the Committee, will become an Associate Member;
- (c) All Club bills and debts incurred to the Club by such Associate Members shall become the responsibility of the spouse concerned;
- (d) The widower of a deceased lady Ordinary Member can continue to remain as an Associate Member of the Club on payment of monthly subscriptions and any other levies prescribed for Lady Members. The Committee shall upon such Associate Member of 20 years good standing as a member and attaining the age of 60 years reduce the monthly subscription payable by him to one half of the monthly subscription payable by a Lady Member;
- (e) Associate Members shall be subject to all the Articles, Regulations and Bye-Laws of the Club but shall have no voice in the management of the Club.
