Article 9 - MEMBERSHIP

No university, college student shall be admitted as a member of the Club unless he or she has obtained written permission from the respective heads of their Institutions.

Article 18 - JUNIOR MEMBERS

- Any child of a Member who has attained the age of 16 but is below 21 years shall, if he wants to enjoy the privileges of the Club, apply to become a Junior Member;
 - (b) Any other child who has attained the age of 16 years but is below 21 years, whether employed or not, may at the discretion of the Committee be admitted as a Junior Member of the Club;
 - (c) A Junior Member has to be proposed and seconded by Members. If the proposer is not the parent of the Junior Member he shall be Joint Guarantor, together with the parents, and they will be liable jointly and severally for all the debts incurred. When the Guarantor of a Junior member ceases to be a Member or becomes an Absent Member or otherwise withdraws his guarantee, the membership of the Junior Member, shall cease unless the guarantee is supplied by another Member.
 - (d) Junior Members shall be subject to all the Articles, Regulations and Bye-Laws of the Club but shall have no voice in the management of the Club. The proposer shall be held responsible for any breach of the Articles, Regulations and Bye-Laws of the Club;
 - (e) Junior Members attaining the age of 21 years shall automatically cease to be Junior Members. They may apply to be Ordinary Members subject to the prevailing Articles and Regulations not withstanding that membership may have been closed under Article 9A.

Article 25 - ENTRANCE FEES AND SUBSCRIPTIONS

(h) Junior Members shall not be liable for entrance fees. The monthly subscriptions payable in advance for Junior Members shall be RM10/= or such sum as may be determined by the Committee from time to time but not exceeding RM40/=.

Article 26 - ELECTION OF MEMBERS

(a) An applicant for membership other than Visiting Members shall complete a prescribed application form and be proposed and seconded by Ordinary Members of at least 3 years standing, to whom the applicant is personally known.
