**Article 16 - VISITING MEMBERS**

- (a) The Committee may on the proposal of an Ordinary, Corporate or Life Member permit any person who has attained the age of 21 years and is temporarily residing in Penang to become a Visiting Member of the Club.

Such privileges will be limited to three (3) visits in one calendar year provided that the aggregate of the three(3) visits shall not exceed 30 days.

Parents and/or children of members on the recommendation of the proposer and seconder shall be eligible for a maximum of 90 days in one calendar year Visiting Membership without any limitation to the number of visits.

- (b) Applicants for Visiting Membership shall sign the prescribed application form and such application shall be considered as accepted on being signed by the President or either of the two Vice-Presidents, or the Hon. Secretary;
- (c) A Visiting Member shall be entitled to all the facilities of the Club except that he shall have no voice in the affairs or management of the Club, shall not enter for any competitions or Inter Club Matches, and shall not be entitled to introduce a guest to the Club;
- (d) No credit facilities shall be extended to a Visiting Member and the proposer shall be responsible for any debt incurred by such a member, including any subscription, and for his conduct in the Club;
- (e) Visiting Members shall be subject to all the Articles, Regulations and Bye-Laws of the Club.

**Article 25 – ENTRANCE FEES AND SUBSCRIPTIONS**

- (i) The daily subscription payable in advance by Visiting Members shall be RM10/= or such sum as may be determined by the Committee from time to time but not exceeding RM40/=.
